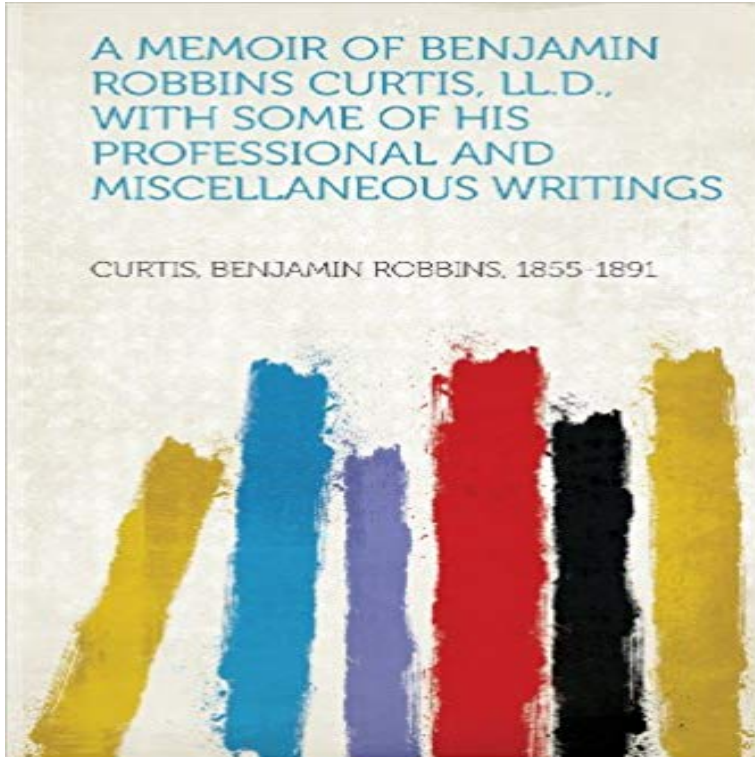


# A Memoir of Benjamin Robbins Curtis, LL.D., With Some of His Professional and Miscellaneous Writings
