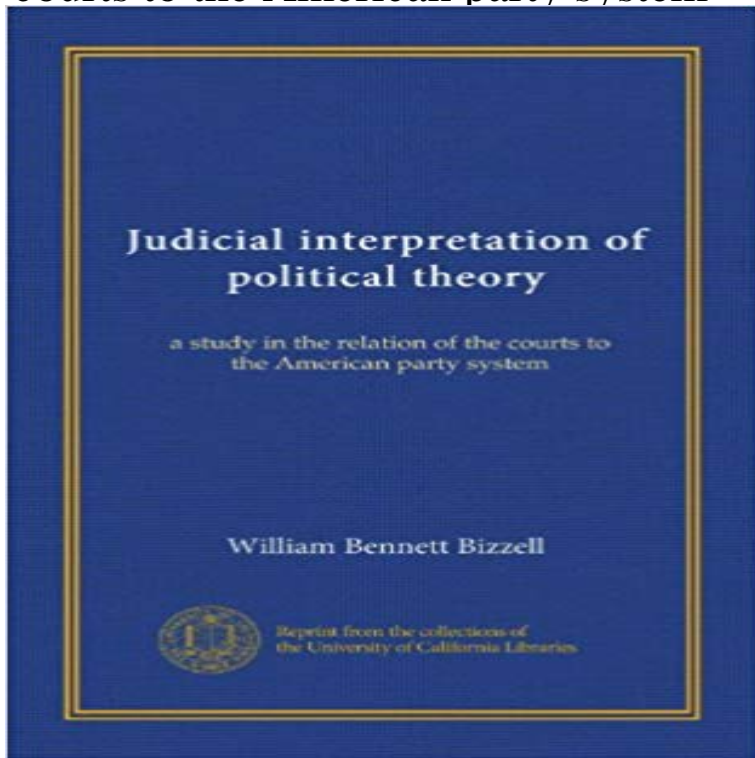


Judicial interpretation of political theory: a study in the relation of the courts to the American party system
