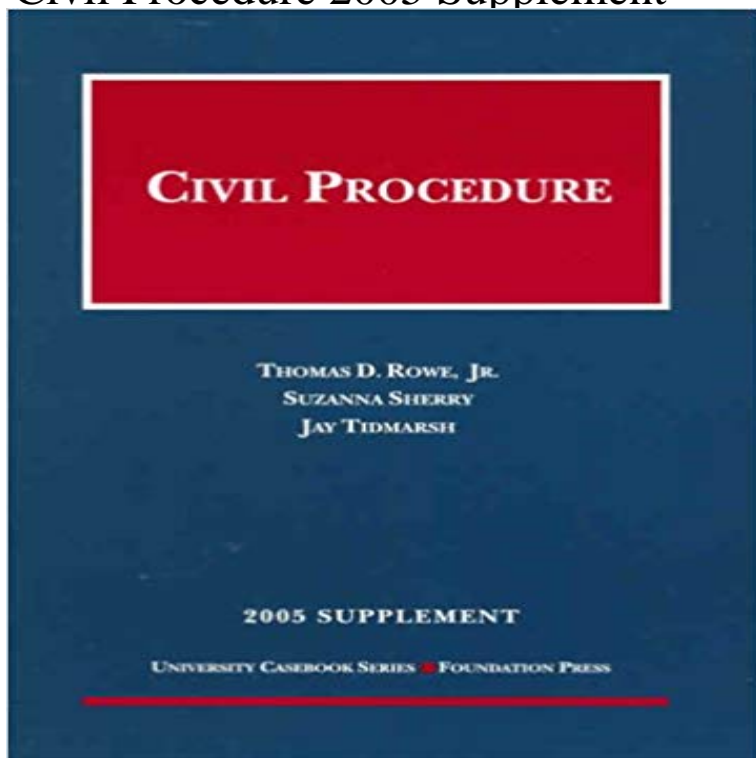


## Civil Procedure 2005 Supplement
